## Southfield Farmers Market Policies



**The following are the hours of operation:  
June 5<sup>th</sup> - October 30<sup>th</sup> 7 a.m. - 4 p.m.**

- 1. Products Allowed for Sale at the Southfield Farmer's Market**  
This market is for the sale of flowers, plants, fruits, organic items, vegetables, herbal products, coffee, tea, meat and seafood products, honey, maple syrup, and other natural and homemade goods. Homemade and/or prepared foods can be sold ONLY if they are prepared in a State Certified kitchen and can provide a copy of a license from the State of Michigan.  
The market welcomes a limited number of crafters whose crafts are kitchen or garden related, or make use of natural, earthy products (i.e. herbal soaps, pottery etc.) This is not a flea market. The Market Manager will review your products to determine suitability for a farmers market.
- 2. Vendors must furnish to the Market Manager a copy of any and all licenses and permits necessary for their operation. Vendors are required to comply with all Michigan Department of Agriculture (MDA) Rules and Regulations. You can contact them at 1-800-292-3939 if you have any questions.**
- 3. The Market Manager reserves the right to assign spaces.**
- 4. Vendor spaces are free. The Market has the right to change this policy in future seasons.**
- 5. If a vendor will not be present on Thursday, they must notify Mary Daley 48 hours prior to market day.**
- 6. All vendors should have neat and tidy signage that is clearly visible.**
- 7. Vendors are expected to leave their booth space clean.**
- 8. Each vendor booth must be under the supervision of a responsible person 18 years of age or older.**

9. Vendors are expected to be present each Thursday unless previously discussed with the Market Master. Vendors are expected to be available to sell from 7 a.m to 4 p.m.
10. Market Manager has the right to deny a vendor the privilege of selling at the Southfield Farmers Market for not adhering to any of the listed policies.
